# **CUT-OFF TIMES FOR SAME DAY EXECUTION**

# Payment Applications in:

- EUR and USD for Retail Division customers are executed within the same day, provided they are received prior to 14:00, between Monday to Thursday
- EUR and USD for IBU and Private Banking customers are executed within the same day, provided they are received prior to 15:00, between Monday to Thursday
   GBP are executed within the same day, provided they are received prior to 15:00, between Monday to Thursday
- RUB are executed within the same day, provided they are received prior to 11:00
- All other currencies are executed with value date two working days after current date, provided they are received prior to 14:00
- Above currencies are executed withing the same day, provided they are received prior ro their cut-off time and provided that no conversion is required. In cases where conversion is required, payments are executed two working days after current date

# Important Note: Outward transfers received on Friday, will be executed within same day provided that are received prior to 13:30

# **APPLIED VALUE DATES**

- Payments in EUR, USD, RUB & GBP are executed with same day value (D)
- Payments in other currencies are executed with 2 working days value (D+2)
