Postal services

Postal services include:

provision of postal address (coincides with company's registered address; postal address is allowed to be shown to the public);

receipt of correspondence, sending of notices of receipt (within first three workdays of each month);

scanning of up to 5 pages per month;

one monthly dispatch of correspondence to office of GSL Law & Consulting.



The cost of postal services is USD 970 per year, including 1 dispatch per month to office of GSL Law & Consulting. Additional courier dispatches of documents from the office to Seychelles are paid for in accordance with received bills.

Postal services include scanning of up to 5 pages of received correspondence per month.

Scanning and sending of additional documents by email are paid for separately (if necessary) – USD 10 per page.

Individual phone line in Seychelles

Services for the provision of a phone line include:

setup of a phone line with an individual phone number – USD 550; one-year maintenance – USD 1 500;

paid separately: per-minute billing, call forwarding to other countries (paid on a per-minute basis based on monthly bills). It is possible to pay for a quarter or a year by transferring a deposit, the minimum amount of which is USD 250.

Lease of an office

The cost of services for entering into an office lease contract is **USD 450** per month.

It is also possible to find an office at request: the cost of services for finding an office varies from 0.5 to 1 monthly rent price.

The average rent price of a small office is USD 1 000 to USD 1 700 per month.

Services of an employee with entering into an employment contract



The minimum salary in Seychelles is SCR 5 250 per month (around USD 360), and both the employer and the employee must monthly transfer 3% of the salary to the social security fund. The employer must also withhold and transfer to the budget the personal income tax on the salary at the following rates:

Salary	Personal income tax rate
Up to SCR 8 555,50	0%
From SCR 8 555,51 to SCR 10 000	15% of amount exceeding SCR 8 555,50
From SCR 10 000,01 to SCR 83 000	SCR 216,68 + 20% of amount exceeding SCR 10 000
From SCR 83 000	SCR 14 883,28 + 30% of amount exceeding SCR 83 000

The cost of services of an employee provided by GSL is USD 450 per month.

In order to pay fees and taxes, a tax number must be obtained for a Seychellois company. The cost of obtaining a tax number is USD 275.

The cost of services for filing a statement in respect of payroll taxes and fees is USD 175 per month for 1 employee.

We also can provide services for finding an employee with certain qualification. The cost of services for staff recruitment and employment of a worker by a Seychellois company (searching for employee, providing resumes of candidates to choose from and holding 3 interviews at most, preparation of employment contract) is:

- **for ordinary employees** one monthly salary;
- **for managers** two monthly salaries

Services for organization of substance in Seychelles[2]



Postal services, including 1 monthly dispatch to office of GSL Law & Consulting	970 per year
Individual phone line	550 (setup). From 1 500 per year (maintenance). 250 (minimum deposit for communications services)
Office lease contract	450 per month
Services of a local employee with whom an employment contract has been entered into	From 450 per month
Services for staff recruitment and employment of a worker by a company (searching for employee, providing resumes of candidates to choose from and holding 3 interviews at most, preparation of employment contract):	
(i) for ordinary employees	one monthly salary
(ii) for managers	two monthly salaries
Preparation and filing of a statement in respect of payroll taxes and fees (for 1 employee)	175 per month
Consultation on efficient reorganization of business for meeting bank requirements	300 per hour
Interaction with a bank for the purpose of finding out and negotiating individual requirements as to substance in the country of incorporation	300 per hour
